Financial aid for college education is available through the Scholars Tuition program. Additionally, Project Success offers college prep and tuition assistance via the Saturday Academy, Collegiate 100 role models, college and job fairs, health fairs, and the Robotics Alliance, ensuring students are well-prepared for their future.
